NOTICE OF COMMENT PERIOD ON APPLICATION COMPLETENESS

Issued: November 6, 2023

In the Matter of the Route Permit Application for the Minnesota Energy Connection Project in Sherburne, Stearns, Kandiyohi, Wright, Meeker, Chippewa, Yellow Medicine, Renville, Redwood, and Lyon counties in Minnesota

PUC Docket Number: E-002/TL-22-132

Comment Period: Initial comment period closes **November 20, 2023**, at 4:30 p.m.

Reply comment period closes **November 27, 2023**, at 4:30 p.m.

Supplemental comment period closes **December 4, 2023**, at 4:30 p.m.

Comments received after the close of the comment period may or may not be considered by the Commission.

Topics for Comment:

- Does the route permit application contain the information required under Minn. R. 7850.1900, subp. 2 and 3?
- Are there any contested issues of fact with respect to the representations made in the application?
- Should an advisory task force be appointed?
- Should the Commission direct the Executive Secretary to issue an authorization to the applicant to initiate consultation with the Minnesota State Historic Preservation Office (See Attachment A)?
- Are there other issues or concerns related to this matter?

Background: Xcel Energy has applied to the Minnesota Public Utilities Commission (Commission) for a route permit to construct the Minnesota Energy Connection (MNEC) Project, a new approximately 171- to 174-mile 345-kilovolt (kV) double-circuit transmission line between the existing Sherburne County Generation Station Substation (Sherco Substation) in the city of Becker in Sherburne County, Minnesota, and a new substation (Terminal Substation) proposed near the town of Garvin in Lyon County, Minnesota. As required by statute, Xcel Energy has proposed two route alternatives that are 171 and 174 miles in length designated as the Purple Route and Blue Route, respectively. Xcel has also proposed four connector segments that would allow options to utilize different portions of each alternative route, as appropriate.

Xcel has generally requested a route width of 1,000 feet and a final right-of-way width of 150 feet. There are several sections of the proposed routes where Xcel Energy has requested wider widths up to the 1.25-mile maximum to enable flexibility in siting.

The proposed MNEC Project would also include:

- A new 3.1-mile single-circuit 345-kV transmission line between the existing Sherco and Sherco Solar West substations in Becker, Minnesota (Green Segment). The new transmission line would be co-located with Xcel Energy's Line 5651, occupying the open position on the existing double-circuit-capable structures.
- Modifications to the existing Sherco Substation and Sherco Solar West Substation.
- A voltage-support substation to be located 80 miles south of the Sherco Substation in either Meeker, Kandiyohi, or Renville County, depending on the final route.
- An intermediate substation to be located 20 miles north of the proposed Terminal Substation near Garvin in Lyon County.

The proposed MNEC Project also requires a certificate of need determination by the Commission because it is a high-voltage transmission line with a capacity greater than 200 kV and greater than 1,500 feet in length. Xcel Energy's March 2023 *Application to the Minnesota Public Utilities Commission for a Certificate of Need for the Minnesota Energy Connection Project* was determined complete by the Commission in an order issued on May 2, 2023. The Commission also authorized use of the informal review process. In a separate order issued on August 10, 2023, the Commission directed joint proceedings to be held on the certificate of need and route permit applications (Docket No. 22-131).

The MNEC Project is part of Xcel Energy's approved 2020-2034 Upper Midwest Integrated Resource Plan (Docket No. 19-368).



Interested Parties:

Through this authorization, the Minnesota Public Utilities Commission (Commission) intends to formalize the role of the Commission, the Department of Commerce—Energy Environmental Review and Analysis (DOC-EERA), and the above listed Applicant for a large electric power facility (as defined in Minn. Stat. § 216E.01, subd. 6) relative to the Commission's statutory responsibilities under Minn. Stat. § 138.665 to consult with the State Historic Preservation Office (SHPO).

In order to streamline the Commission's compliance with Minn. Stat. § 138.665, the Commission hereby authorizes the Applicant to initiate consultation with SHPO pursuant to Minn. Stat. § 138.665. Effective immediately, the Applicant and its authorized representatives may consult with SHPO to initiate review and consultation. Specifically, the Applicant is

authorized to gather information to identify, and reevaluate if warranted, designated historic properties, and to work in coordination with other interested entities, including Tribal Nations and DOC-EERA, to assess the effects of proposed projects on designated historic properties as described in Minn. Stat. § 138.665. As appropriate, as part of its environmental review, DOC-EERA will coordinate with SHPO in evaluating the potential effect of alternative sites and routes on historic properties as described in Minn. Stat. § 138.665.

The Commission sits in a quasi-judicial capacity and makes siting and routing decisions based solely on the administrative record developed and the comments and information submitted by the parties and participants to Commission proceedings. The Commission is also subject to Minnesota's Open Meeting Law, Minn. Stat. Ch. 13D, which requires that Commission meetings be open to the public and the record be publicly available. Ex parte communications with Commissioners are prohibited, and Commissioners hear from interested entities and people onthe-record, either through written filings or at agenda meetings that are open to the public.

Accordingly, at the time the Applicant submits its prehearing testimony prior to the public hearing on the project, the Applicant shall file a compliance filing informing the Commission of the status of consultation with SHPO. This compliance filing should demonstrate that consultation has occurred, whether the proposed project will affect designated properties, and if so, identify any permit terms and conditions agreed upon by the applicant and SHPO to avoid or mitigate any adverse effects on the designated or listed properties. The Applicant should attach to its compliance filing a letter obtained from SHPO confirming that consultation has occurred and detailing any comments, concerns, and/or recommendations regarding the project from SHPO. If SHPO objects to the proposed project, this letter should detail SHPO's objection and any proposed permit terms and conditions that, if adopted, would resolve its objection. If SHPO's objection cannot be addressed through appropriate permit terms and conditions, the SHPO may request mediation as provided for in Minn. Stat. § 138.665.

Notwithstanding this authorization, the Commission retains ultimate responsibility for consultation under Minn. Stat. § 138.665 and for determining whether to permit a large electric power facility.


