YOUR LEGISLATORS' VOTING RECORD ON SMALL BUSINESS ISSUES | 2020 EDITION

2019-2020 session roll call votes by your state legislators on key small business issues are listed here. Although this Voting Record does not reflect all elements considered by a lawmaker when voting, nor does it represent a complete profile of a legislator, it can be a guide in evaluating your legislators' attitudes toward small business. Please thank those legislators who supported small business.

HOUSE AND SENATE

- 1. HB 2569 (2019):** Allows Arizona to recognize other states' occupational licenses. Under the bill, licensed professionals who move to Arizona can get back to work as soon as possible. Arizona already implemented many of these reforms in 2011 for spouses of members of the military. This bill allows professionals from other states who have held their license for at least a year and are in good standing in all the states they're licensed in to practice in Arizona under the oversight of the corresponding Arizona regulatory agency. **A "Yes" vote supports the NFIB position.** Passed the House 36-24. Passed the Senate 18-11. Signed by the governor.
- 2. HB 2757 (2019):** Includes individual income tax rate reductions as well as a reduction in the number of tax brackets from 5 to 4. Provides rate reductions for all taxpayers. Conforms Arizona's state income tax code to the Federal 2017 Tax Cuts and Jobs Act; consistent with the principle of seeking a more neutral tax code by broadening the tax base and lowering rates. Simplifies Arizona's Transaction Privilege Tax in alignment with the U.S. Supreme Court's *Wayfair* decision by recognizing one tax base for retail and other transactions through state law rather than through local jurisdictional rules. Establishes the option of an online marketplace, marketplace facilitator, marketplace seller and remote seller for the purposes of Transaction Privilege Tax collection and remittance by online retailers. **A "Yes" vote supports the NFIB position.** Passed the House 31-29. Passed the Senate 16-13. Signed by the governor.
- 3. SB 1397 (2019):** Streamlines processes and makes various changes to statutes relating to the Registrar of Contractors and the regulation of licensed residential contractors. **A "Yes" vote supports the NFIB position.** Passed the House 59-0. Passed the Senate 30-0. Signed by the governor.
- 4. HB 2686 (2020):** This legislation is in response to a startling policy trend that began in Berkeley, California

in July of 2019. The legislation reinforces the State's authority to set energy policy in Arizona and preserves an individual's ability to use the services of a utility provider that is authorized to serve them. Specifically, the legislation prohibits a city, town, or county from denying a building permit or charging discriminatory fees based on the utility provider proposed to serve a project and protects Arizonans from being forced to convert appliances. **A "Yes" vote supports the NFIB position.** Passed the House 36-23. Passed the Senate 19-10. Signed by the governor.

- 5. SB 1113 (2020):** Specifies what information must be included in a tax statement that is sent by a county treasurer to a mortgagor of a property. Requires a tax statement from a county treasurer to separately list the property tax information for the current and previous tax years that is due to each taxing jurisdiction. **A "Yes" vote supports the NFIB position.** Passed the House 58-0. Passed the Senate 30-0. Signed by the governor.

SENATE ONLY

- 6. SB 1449 (2020):** Protects retailers and other sellers of products from being brought into product liability lawsuits except for in certain circumstances where the seller may have contributed to a product defect. **A "Yes" vote supports the NFIB position.** Passed the Senate 19-11.

HOUSE ONLY

- 7. HB 2184 (2020):** Adds a requirement for licensing agencies subject to Arizona's occupational and professional reciprocity law (HB 2569 2019). Requires an occupational or professional regulating entity to print a prescribed statement relating to Arizona occupational and professional reciprocity law on all license and certificate applications and regulating entity websites. **A "Yes" vote supports the NFIB position.** Passed the House 60-0. Failed in the Senate 11-35.
