Votes by your state legislators on key small business issues are listed here. Although this Voting Record does not reflect all elements considered by a lawmaker when voting, nor does it represent a complete profile of a legislator, it can be a guide in evaluating your legislator's attitudes toward small business. Please thank those legislators who supported small business.

BOTH CHAMBERS

1. Service Worker Protection Act (2024 - SB233):

Creates protections for service employees when there is a change in ownership. Protections include a 15-day notice prior to change and all affected employees are kept during a 90-day transitional period. **A "NO" vote supports the NFIB position.** Passed the Senate 15-5. Passed the House 25-13. Awaiting action by the governor.

2. Polystyrene Ban (2023 - SB51): Prohibits food service establishments from providing customers with ready-to-eat food or beverages in polystyrene foam containers. It also bans single-service plastic coffee stirrers, cocktail picks, or sandwich picks as well as plastic straws unless the straw is requested by a customer. **A "NO" vote supports the NFIB position.** Passed the Senate 15-5. Passed the House 29-11. Signed by the governor.

3. Online Data Privacy (2023 - HB154): Establishes requirements on businesses that control or process consumer data including the establishment of a method for allowing consumers to opt out or revoke consent to maintain or sell their data. **A "NO" vote supports the NFIB position.** Passed the Senate 15-5. Passed the House 37-3. Signed by the governor.

4. Labor Dues Tax Deduction (2023 - SB72): Allows labor union members to claim a tax deduction on either federal or state income tax returns of \$500 for their membership expense. **A "NO" vote supports the NFIB position.** Passed the Senate 17-3. Passed the House 26-12. Signed by the governor.

5. Unemployment Insurance (UI) Changes (2024 - HB433): Revises the experience rating methodology for assigning UI tax rates to employers. It also reduces new employer assessment rates. **A "YES"**

vote supports the NFIB position. Passed the Senate 21-0. Passed the House 40-0. Awaiting action by the governor.

6. Prevailing Wage Expansion Offsite (2023 - SB102): Expands the requirement for a contractor to pay the state's prevailing wage to include offsite fabrication of materials used for a public works project. **A "NO" vote supports the NFIB position.** Passed the Senate 15-4. Passed the House 29-12. Signed by the governor.

7. Housing Status in Employment (2024 - HB440): Adds "housing status" as a protected characteristic in Delaware employment law. **A "NO" vote supports the NFIB position.** Passed the Senate 20-1. Passed the House 35-0. Awaiting action by the governor.

8. Delaware Climate Change Solutions Act of 2023 (2023 - HB99): Requires state to reduce greenhouse gas emissions 50% of a 2005 baseline by 2030 and become net zero by 2050. All state agencies must consider GHG emissions goals when promulgating regulations. **A "NO" vote supports the NFIB position.** Passed the Senate 15-5. Passed the House 27-13. Signed by the governor.

9. Solar-Ready Commercial Property (2023 - HB11): Requires all new commercial property with a footprint of 50,000 square feet or greater to be built as "solar ready" for the installation of solar photovoltaic or solar thermal systems. **A "NO" vote supports the NFIB position.** Passed the Senate 16-4. Passed the House 24-14. Signed by the governor.

HOUSE ONLY

10. Clean Cars II Authorization (2023 - HB123):

Requires the Delaware Department of Natural Resources and Environmental Control to obtain the consent of the General Assembly before promulgating regulations that would restrict the sale of fuel-powered vehicles. **A "YES" vote supports the NFIB position.** Passed the House 21-20. Failed to receive a vote in the Senate.

11. Standard Deduction for Personal Income Tax

(2023 - HB89): Increases the standard deduction for personal income tax purposes for resident individuals and spouses. **A "YES" vote supports the NFIB position.** Passed the House 39-0. Failed to receive a vote in the Senate.
